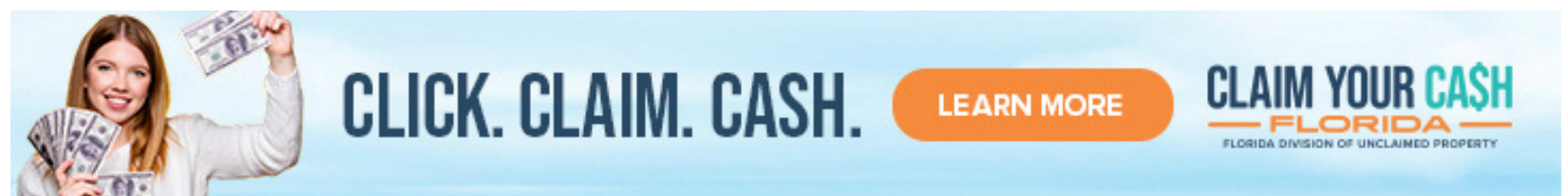
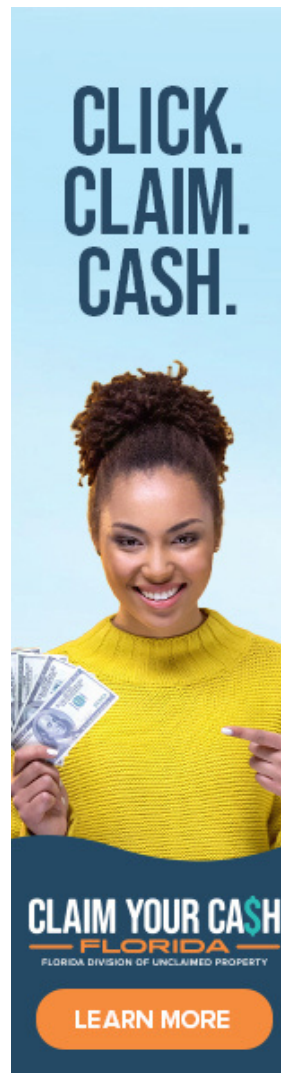

We're excited to share that the Florida Department of Financial Services, Division of Unclaimed Property, has launched [Claim Your Cash Florida](#), a statewide awareness initiative designed to reconnect individuals, families, and businesses with money that may already belong to them.

Life happens. Whether you've moved, changed jobs, closed a financial account, or managed a loved one's estate, financial assets can sometimes be left behind. In fact, about one in five Floridians has money currently being safeguarded by the State of Florida until it can be returned to its rightful owner.

Abandoned property is not land or real estate. It is money or other financial assets that have been lost, forgotten, or left inactive. When businesses and financial institutions cannot locate the rightful owner after making a good-faith effort, Florida law requires them to transfer the property to the Division for safekeeping.

Abandoned property may include:

- Forgotten bank accounts
- Uncashed payroll or refund checks
- Utility deposits
- Insurance proceeds
- Stocks and dividends
- Other financial assets

The good news is that searching for abandoned property is secure, fast, and always free.

Take a few minutes to search your name, your business, or even the name of a family member. You may be surprised to discover money that's already yours waiting to be claimed.
